EPA 8-HOUR HAZWOPER REFRESHER DIRECTIONS

Every year for the last 25 years, EPA Emergency Response in Southern California has provided numerous local agencies with in-person 8-Hour HAZWOPER Refresher Training. In 2020, due to the COVID-19 pandemic, EPA was unable to present these trainings in-person. To make up for this, EPA Emergency Response has transformed their live 8-Hour Refresher Training into a narrated virtual PowerPoint Class which will remain available post-COVID as well. The 8-Hour Refresher consists of 13 modules which are listed below. Each Module, except for 6 and 7 have an accompanying Worksheet. Modules 6 and 7 have a combined worksheet. Module 14 contains the final exam.

Modules 1-5 and 8-11 are mandatory for all students. If you wear respiratory protection and PPE in your job, Modules 6-7 are also mandatory. Modules 12 and 13 are optional. If you conduct emergency response or site cleanup, EPA recommends taking Modules 12 and 13.

Once you've finished with the Presentation, download and complete the **WORKSHEET** before moving on to the next Presentation. When you've completed all the mandatory presentations, you may take the test.

The Test is labeled under Module 14. After completing the test, have your supervisor email Robert Wise at wise.robert@epa.gov to request the **TEST KEY** along with a copy of the Certificate template for your Agency to self-certify that you completed your annual HAZWOPER Refresher training.
